We understand that St Peter Chanel Catholic School will

- Do its best to keep the school cyber-safe by maintaining an effective cyber safety programme. This includes working to restrict access to inappropriate, harmful or illegal material on the Internet or school ICT (Information and Communication Technology) equipment/devices at school or at school-related activities.
- To enforce and comply with the cyber-safety rules and requirements detailed in our policies.
- Keep a signed copy of this Cyber-safety Use Agreement on file.
- Respond appropriately to any breaches and/or complaints regarding cyber safety.
- To welcome enquires from students and/or parents/guardians/caregivers about cyber-safety issues.

### **Student**

My responsibilities include:

1. I will read this Cyber-safety Use Agreement carefully.
2. I will follow the cyber safety rules and instructions wherever I use the school's ICT.
3. I will also follow the cyber safety rules whenever I use privately-owned ICT on the school site or at any school-related activity, regardless of its location.
4. I will avoid any involvement with material or activities which could put at risk my own safety, privacy of the school or other members of the school community.
5. I will avoid any involvement with material or activities which could bring the school's name or image in the community into disrepute.
6. I will take proper care of school ICT. I know that if I have been involved in the damage, loss or theft of any ICT equipment or devices, I may incur the cost of its repair or replacement.
7. I will keep this document somewhere safe so that I can refer to it in the future.
8. I will ask my class teacher or a member of staff if I am not sure about anything to do with this agreement.
